This event will give students the opportunity to learn about and practice, safe bicycling skills. Volunteers from **Black Tooth Grin Bike Shop** at 422 Dunlop Street West in Barrie, will be on hand to inspect student's bikes and helmets prior to entering the rodeo. Certificates will be given out to all participants!

Each student is required to bring a bicycle, a helmet, and a signed **Waiver Form**** to participate in the rodeo. For safety reasons, parents/guardians must be in attendance. Registration begins at 5:00 p.m. at the registration table. **Chevy's Big Bite** will be serving up hamburgers, hot dogs, French fries and funnel cakes throughout the evening. We will also be offering pop, water and Jumbo freezies. Please see the attached order form as food must be ordered in advance. There will be limited sales of food available the night of the event. Please return the food order forms by Wednesday, May, 27th. Pre-ordered food tickets and wrist bands to participate, will be handed out at the time of registration.

This is a school-wide family and community event. It will be a fun-filled evening of activities including a climbing slide and a fun zone. We are also excited about having the Skateboard Park at the school, for those wishing to practice and show-off their skateboarding skills. The event will take place, RAIN or SHINE!

I affirm that I am, and/or my child is, in good health and at an appropriate level of physical fitness and physical capability to participate in the Activity. I affirm that I am at least 18 years of age, or that I am the parent and/or legal guardian of the child listed below and I hereby consent to their participation and waive liability on their behalf.

CONSENT TO USE IMAGE ----I hereby consent and authorize MCS to take my photograph/image and/or the photograph/image of the child listed below, for whom I am the parent and/or legal guardian (collectively, "Image"). I acknowledge and agree that MCS may publish, display or use the Image for any MCS purpose and by any means whatsoever including, but not limited to, electronic or digital means.
